By entering Warner Music Australia Pty Limited's ("Warner") "PRE-SAVE/PRE-ADD BIFFY CLYRO – A CELEBRATION OF ENDINGS TO WIN" Promotion you are agreeing to the following terms and conditions:

#### 1. STANDARD TERMS

1.1 Information and instructions on "How to Enter" form part of these conditions of entry.
By entering the Promotion, entrants accept and agree to be bound by these conditions of entry.

#### 2. WHO CAN ENTER?

- 2.1 The only persons who may enter and be awarded the prize are those who:
  - a) are residents of Australia; and
  - b) are 16 years of age or older, entrants under the age of 18 must seek prior permission from their parent or guardian to enter this Promotion. Any such entrant without this permission is not eligible to enter the Promotion;

- 4.2 To enter via your Spotify:

  - (b) Step 2: Follow the prompts on the Promotion Page and login to your Spotify account or use your personal Facebook Connect to login to your Spotify account and accept the terms and conditions.
  - (c) Step 3: Pre-save the **Biffy Clyro** album entitled "A Celebration of Endings" on Spotify ("the Artist's Spotify Album") (compulsory).
    - When you pre-save the **Artist's Spotify Album** on Spotify, the following information will be collected from your Spotify account: your registration data (name, username,

email address, date of birth, gender, postal code and country). If you connect to the service using credentials from a Third Party Application (as defined in the Terms and Conditions of Use of Spotify) (e.g., Facebook), you authorise Spotify to collect your authentication information, such as your username and encrypted access credentials, which we will then collect via such Third Party Application. We may also collect other information available on or through your Third Party Application account, including, for example, your name, profile picture, country, hometown, email address, date of birth, gender, friends' names and profile pictures, and networks.

- (d) Step 4: By entering these details on the Promotion Page you acknowledge you are opting-in to the official Maniacs mailing list (optional) and the official Biffy Clyro mailing list (optional), and accept the terms and conditions (compulsory)
- 4.3 To enter via your Apple Music:
  - (a) Step 1: Go to the Promotion Page;
  - (b) Step 2: Follow the prompts on the Promotion Page and login to your Apple Music account and accept the terms and conditions.
  - (c) Step 3: Pre-add the **Biffy Clyro** album entitled **"A Celebration of Endings"** on Apple Music ("the Artist's Apple Album") (compulsory);
    - When you pre-add the **Artist's Apple Album** on Apple Music the following information will be collected from your Apple music account: the account, IP address, and device, app, or car interface you used to play, where in Apple Music you were when you played it, the time you played it and for how long, is noted by and sent to Apple. All of this information is collected and used in accordance with Apple's privacy policy which can be found at <a href="https://www.apple.com/privacy/">https://www.apple.com/privacy/</a>
  - (d) Step 4: By entering via the Promotion Page you acknowledge you are opting-in to the official Maniacs mailing list (optional) and the official Biffy Clyro mailing list (optional) and accept the terms and conditions (compulsory).
- 4.4 Entrants must enter by 11.59pm (AEST) on 13 August 2020 to be eligible to win the prize. The time of entry will in each case be the time the registration is received by the Warner database. No responsibility is accepted for late, incomplete, lost or misdirected entries.

Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
